## 1. Introduction

**Start Date:** 00:00:00 (UTC) 26 January 2023 i.e. 5:30:00 (UTC) 26 January 2023

**End Date:** 23:59:59 (UTC) 29 January 2023 i.e. 5:29:59 (IST) 30 January 2023

## 3. Offer

### A) For First 3 months w.e.f. 26<sup>th</sup>, 27<sup>th</sup>, 28<sup>th</sup> & 29<sup>th</sup> January 2023

**1 year** new creates of 2<sup>nd</sup> level and 3<sup>rd</sup> level .IN/.भारत domains will be provided to the Registrars for **FREE** for a period of **3 months with an additional bonus amount per domain** during the promotion term. Promotion scheme is **FOUR DAYS** i.e. from 26 January 2023 to 29 January 2023.

**Registrars are required to provide the domains for FREE to the Registrants during the promotion term.**

Amount will be credited to the Registrar's account as per the dates communicated in the reimbursement mail.
