

## .IN Holi Special 2024 - Extended

## 1. Introduction

Due to the success of the Holi Special 2024 promotion and requests from many partners, we are happy to announce the extension of the promotional offer. All details, targets, goals, etc remain the same. However, as this is an opt-in promotion, we request partners to fill the <u>form</u> to sign-up for this offer.

Please note: Registrars that opted in previously will be required to opt-in and fill the form again if they wish to participate during the extended promotional dates.

### 2. Duration

Start: 00:00:00 (IST) 16 April 2024 i.e. 18:30:00 (UTC) 15 April 2024 End: 23:59:59 (IST) 30 April 2024 i.e. 18:29:59 (UTC) 30 April 2024

### 3. Goal

Discounts available through this promotional offer are based on a Registrar's growth % from half monthly average new creates from April 2023 to February 2024.

Registrars with half monthly average new creates of more than 12 domains from April 2023 to February 2024 will receive a 25% discount for a growth of 10%-19.9% and a 50% discount for a growth of 20% and above.

Registrars with half monthly average new creates of less than 12 domains from April 2023 to February 2024 will be eligible for a 10% discount only if they register a minimum of 12 new creates during the promotion term.

#### Please Note:

- This is an opt-in promotion. Registrars are requested to fill this <u>form</u> if you wish to enroll for this promotion.
- Registrars opting in for this promotional offer will be required to prominently place the TLD on their website during the promotion term.
- Registrars opting in for the promotion will be required to offer the discounts to their end customers..
- Discounts will NOT be offered to Registrars if the above criteria is not met, in spite of meeting growth targets.
- Discounts will be provided to eligible Registrars after the end of the promotional offer.

# 4. Program Terms and Conditions

- All .IN Registrars are eligible for this program.
- The Growth Promotion is applicable to one year new creates of 2<sup>nd</sup> level and 3<sup>rd</sup> level .IN/.भारत domains only :
  - o Second Level .IN/.भारत registrations e.g. example.in/उदाहरण.भारत
  - o Third Level .IN/.भारत registrations e.g. example.co.in/उदाहरण.कंपनी.भारत
- The discounts are applicable to both .IN and IDNs and their respective zones.
- Registrars are required to opt-in for the promotion by filling in the <u>Opt-in Form</u> latest by 15 April 2024.
- Eligible Registrars will receive the discount amount for applicable domain names only after submitting an invoice/debit note.
- The discount amount to eligible Registrars will be offered as reimbursements:
  - The discount amount for the applicable domain names will be communicated to the eligible Registrars after the end of the promotion term.
  - Registrars are required to submit an invoice (for GST applicable Registrars) or a Debit
     Note (for non-GST Registrars) to receive the applicable discount amount.
  - Invoice/Debit Note should be sent to <u>accounts@nixi.in</u> and <u>registry@nixi.in</u> as per the timelines that will be communicated in the reimbursement amount email.
  - Discount amount in the form of reimbursements will reflect in Registrar account by the dates communicated in the reimbursement mail.
- Retail pricing of domains is at the discretion of the Registrar. However, Registrars are encouraged
  to offer aggressive pricing discounts to customers, in accordance with the program's discount
  structure. The same is suggested for promoting discounted pricing on customer interface/website.
